PRIVATE LESSON (MUSC 106) CONTRACT

This form indicates that an agreement has been made between the student and faculty member listed below for the delivery of individualized music instruction.

Student:

It is your responsibility to contact your instructor prior to missing any lessons. Instructors are not obligated to provide make-up lessons for any session cancelled by the student with less than 24 hours notice. The instructor is only obligated to re-schedule a maximum of 2 lessons per semester. Signing the contract is not the same as enrolling for the course; you must also register for Private Lessons through Enrollment Services (or through the Banner system) to be enrolled. You are responsible for withdrawing from your lessons through Enrollment Services if you cease attending; failure to withdraw from lessons may result in a 0.0 grade. Instructors *may* drop non-attending students, but are not obligated to do so. Music Majors enrolled in Private Lessons are required to participate in an LCC performance ensemble (failure to enroll in an LCC performance ensemble will result in Administrative Withdrawal from Private Lessons). Theatre Majors enrolled in Private Lessons are not required to participate in an LCC performance ensemble.
